By submitting your membership or coaching application form you agree to be bound by the following terms and conditions.

8. INCREASE OF PRICES:

- IF YOU HAVE PAID A DEPOSIT AND A PRICE INCREASE INCURS, YOU ARE NOT REQUIRED TO PAY THE INCREASE PRICES

10. WARNING UNDER THE AUSTRALIAN CONSUMER LAW AND FAIR TRADING ACT 2012

Under section 22 of the Australian Consumer Law and Fair Trading Act 2012, the supplier is entitled to ask you to agree that these statutory guarantees do not apply to you. If you sign this form, you will be agreeing that your rights to sue the supplier under the Australian Consumer Law and Fair Trading Act 2012 if you are killed or injured because the services provided were not in accordance with these guarantees, are excluded, restricted or modified in the way set out in this form. You release and indemnify HTCC/CTS to the full extent permitted by law in respect of any claim, loss, liability or expense arising as a result of or in connection with your participation in any HTCC/CTS activity. While all efforts are made to ensure your safety, TW takes no responsibility for injury, damage or loss of property.

12. PRIVACY AND IMAGE RIGHTS

12.1. By using the Venue, you consent to your image being taken, retained and reproduced during your participation in CTS programs and activities by or on behalf of HTCC.
